Resolution To Approving Charter Notation for Section 4.10 of the City Charter Moved by Lambert, seconded by Porter that we accept and adopt the following resolution:

WHEREAS the City Charter Section 4.10 pertaining to the City Library is no longer followed as a result of the Community District Library Agreement ("Agreement") to which the City of Perry is a participating member; and

WHEREAS the City, desires to make it clear to its community and reduce any confusion as to why the Section 4.10 of the City Charter is not followed; and

WHEREAS, the City Attorney having been in consultation with the Michigan Attorney General's office concerning this issue and having determined that the Agreement controls the requirement of the City with regard to the Library and no amendment of the Charter is necessary;

THEREFORE, IT IS RESOLVED THAT the City shall authorize a notation to be made to the Section 4.10 of the City Charter to state:

\*The Community District Library Agreement, along with any amendments thereto, supersede the City Charter and therefore Section 4.10 of the City of Perry Charter is no longer in effect. Any person may review a copy of the Community District Library Agreement and all amendments thereto at City Hall.

Carried all yes.
